Gentlemen:

See the enclosed annual report packet and note the mailing address notice. This packet was just received by a registered agent of the corporation. The date (7/7/98) is recorded. It was delivered July 8, 1998. I realize this is past the due date, but as you can see, there is good reason. Hydrosplash is a Tennessee Corporation that is totally inactive since its inception in 1989. We have paid tax on time, each year, the last payment being January 15, 1997. We have done no business in Florida.

We cannot afford to pay \$550 at this time. We do not understand why we have to file in Florida in any event, and if we do not file, what is the consequence seeing Hydrosplash is a Tennessee Corporation? We are willing to pay the \$165 fee in the event we decide to do business in Florida.
