The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

# ARTICLE I NAME AND ADDRESS

The name of the Corporation is Regional Rehab Therapy Associates, P.A. The principal office and mailing address of the Corporation is 1865 Veterans Park Drive, Suite 101, Naples, FL 34109.

#### ARTICLE II: DURATION

The duration of the Corporation is perpetual.

## ARTICLE III: PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To provide physical therapy and rehabilitation treatments as well as associated services.
- B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
