The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is Network Holdings, Inc., and it maintains a physical and mailing address at 13 Sunset Bay Drive, Bellair, Florida 33756.

**ARTICLE II**

**Commencement and Term of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State. This Corporation shall have perpetual existence.

**ARTICLE III**

**General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

**ARTICLE IV**

**Capital Stock**

**By-Laws**






**CERTIFICATE DESIGNATING
