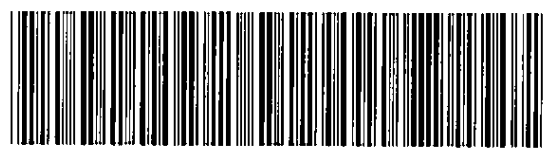

ARTICLES OF INCORPORATION

The undersigned, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

ARTICLE I
CORPORATE NAME

The name of this Corporation shall be:

ARTICLE II
NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be to engage in every aspect of the practice of medicine. The professional services rendered by the corporation may be rendered only through individuals duly licensed to render professional services as medical doctors/physicians under the laws of the State of Florida as defined in Chapter 621, Florida Statutes. The Corporation shall not engage in any business other than the practice of medicine and to do all and everything necessary and proper for the accomplishment or furtherance of any of the purposes enumerated in these Articles of Incorporation, any amendments thereof, or which are necessary or incidental to the accomplishment of the purpose of this Corporation organized under Chapter 621 Florida Statutes. Additionally, the Corporation may borrow funds, take out loans, invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own real and personal property reasonably necessary for the rendering of professional medical services or furthering the purposes of these Articles.

The common stock of the Corporation may not be issued to anyone other than an individual who is duly licensed to render professional medical services.

The total authorized capital stock of this Corporation is One Thousand (1,000) shares of Common Stock, par value \$.01 per share.
