

# ARTICLES OF INCORPORATION OF PRS BEACH 18, INC.

The undersigned, acting as incorporator of PRS Beach 18, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation is PRS Beach 18, Inc. (the "Corporation").
