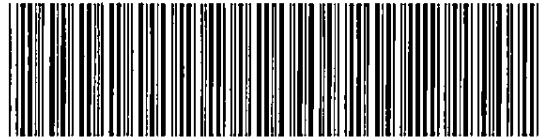



ARTICLES OF INCORPORATION
OF
SPUSA REAL ESTATE HOLDINGS INC.

Pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, the undersigned incorporator **SPUSA REAL ESTATE HOLDINGS INC., a Florida corporation** (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I
NAME AND PRINCIPAL & MAILING ADDRESS

The name of the Corporation is SPUSA REAL ESTATE HOLDINGS INC. The Corporation's initial principal office and mailing address is 3521 Russell Road, Marianna, FL 32446.

ARTICLE II
PURPOSE


