ARTICLES OF INCORPORATION

OF

MILLENNIUM SKIES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is MILLENNIUM SKIES, INC. (the "Corporation").

ARTICLE II. ADDRESS

The principal and mailing address of the Corporation is 1000 Brickell Avenue Suite 300, Miami, FL 33131.

ARTICLE III. REGISTERED OFFICE AND AGENT

ARTICLE IV. DURATION

The duration of the Corporation is perpetual.

The general purposes for which the Corporation is organized are:

- (1) To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

The aggregate number of shares which the Corporation is authorized to issue and have outstanding at any time is ONE HUNDRED (100) shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share. The foregoing may be amended at any time as provided in the Bylaws of the Corporation and by applicable law.

ARTICLE VIII. DIRECTORS

The Directors of the Corporation shall be elected, appointed, and removed from office by a majority of the Shareholders or as otherwise specified in the By-Laws of the Corporation. The number of Directors constituting the Board of Directors of the Corporation shall be determined in accordance with the By-Laws but shall not be less than one (1). The number of Directors constituting the initial Board of Directors is (2). The name and address of the persons who shall serve as the initial Directors of the Corporation are:
