Article IV of the Articles of Incorporation of this Corporation is hereby deleted in its entirety and replaced by the following provision so that, upon filing these Articles of Amendment, said Article IV shall read as follows:

ARTICLE IV - SHARES

The total number of shares that the Corporation is authorized to issue and have outstanding at any time is 15,000 shares consisting of (a) 8,200 shares of Class A common stock with no par value, with each share having two votes, and (b) 6,800 shares of Class B common stock with no par value, with each share having one vote.

The Articles of Incorporation of this Corporation are hereby amended by the addition of a new Article IX, so that, upon filing these Articles of Amendment, said Article IX shall read as follows:

ARTICLE IX -- WEIGHTED VOTING

The shareholders may by written agreement designate that certain directors shall have more than one vote. The shareholders shall specify in their written agreement the number of votes each designated director shall have at the time of such designation.
