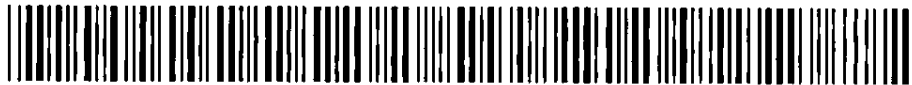

**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **EPOQUE INC.**, a Florida corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation is Epoque, Inc.
2. The original Articles of Incorporation of the Corporation (the "Articles") were filed on February 12, 2024, and assigned Document No. P24000011611, an amended by that certain Articles of Amendment to Articles of Incorporation filed on July 2, 2024.
3. The following amendment to the Articles was adopted by the Shareholders and Directors of the Corporation by written consent dated September 27, 2024, in accordance with the provisions of Sections 607.0821 and 607.0704 of the Florida Statutes. The directors and officers of the Corporation shall be as follows:


