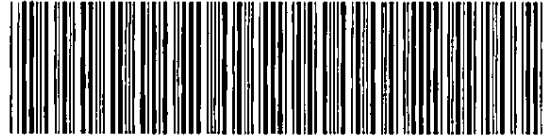

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

### **Article I      Name**

The name of the corporation shall be Bluefish Technologies, Inc.

### **Article II      Principal Office**

The principal street address and mailing address shall be 3435 Coldwell Drive, Holiday, Florida 34691.

### **Article III      Statement and Business Purpose**

The corporation is organized for the purpose of transacting any or all lawful business for which a corporation may be incorporated under the laws of the State of Florida, as amended from time to time.
