ARTICLES OF INCORPORATION
OF SECRETARY OF STATE
LIGHTNING SELLER, INC. FLORIDA

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Business Corporation Act, and pursuant to the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is:
Lightning Seller, Inc.
(hereafter, the "Corporation").

ARTICLE II

Duration

The Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE III

Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 10444 Green Links Drive, Tampa, FL 33626.

ARTICLE IV

Capital Stock

The Corporation is authorized to issue fifty thousand (50,000) shares of voting common stock, and ten thousand (10,000) shares of non-voting common stock, each with a par value of one cent (\$.01). The voting common stock and the non-voting common stock shall have identical rights except that the nonvoting common stock shall not entitle the holder thereof to vote on any matter unless specifically required by law.

ARTICLE VIII**Indemnification**

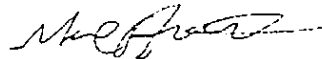
The Corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.
