**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, Erica Richards, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is RAINEY'S MARKETPLACE, INC. The Corporation is referred to in these Articles of Incorporation as the "Corporation."
