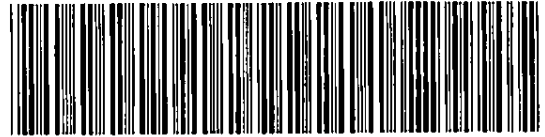

**ARTICLES OF INCORPORATION  
OF  
RMS ORLANDO HOLDINGS, INC.**

**a Florida corporation**

In compliance with the requirements of Chapter 607 and/or Chapter 621, F.S., of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation shall be RMS ORLANDO HOLDINGS, INC.

**ARTICLE II: INITIAL PRINCIPAL OFFICE**

The street and mailing address of the initial principal office of the Corporation is 122 E. Kimberly Lane, Palatine, IL 60067.

**ARTICLE III: PURPOSE**
