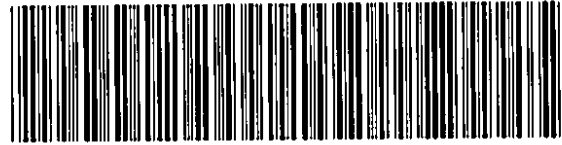

Pursuant to the provisions of Section 607.1105 of the Florida Business Corporation Act (the "FBCA") and for the purpose of effectuating the merger (the "Merger") of Moonlight Payments LLC, a Puerto Rico limited liability company ("MP LLC") with an into Moonlight Payments Inc., a Florida corporation ("MP INC"):

In connection with the Merger, that certain agreement and plan of merger entered into between MP LLC and MP INC (the "Agreement and Plan of Merger") and these Articles of Merger were recommended for approval by the sole director of MP INC and was also approved, adopted, ratified and confirmed by the sole shareholder of MP INC.
