AFFIDAVIT REGARDING RECORDED GOVERNING DOCUMENT

I, Olesea Azevedo, hereby certify as follows:

- I am eighteen years of age or older, have personal knowledge and sufficient experience to testify to the matters stated herein and am competent to be a witness in a legal proceeding.
- 2. I am submitting this Affidavit in support of my request that the State of Florida promptly revoke the registration of Oxford Close, Inc.
- 3. The following information concerns the filing that is the subject of this affidavit:
 - a. Name of Entity for which filing was recorded: Oxford Close Inc.
 - b. Department Identification Number: P24000025407
 - c. Date filing was recorded: April 12, 2024
- 4. The registration of Oxford Close Inc. ("Corporation") was an act of fraud upon the State of Florida. I am listed as the incorporator of the Corporation, but I did not create or register the Corporation, nor did I authorize any such actions. I have been the victim of identity theft arising, so far as I can tell, from a data breach at AT&T. I learned that the Corporation had been registered when I received from LegalZoom copies of the incorporating documents on April 19, 2024. I have attached hereto a copy of the materials that I received from LegalZoom.
- 5. I did not go on the website https://dos.fl.gov/sunbiz to create or request this incorporation. I did not provide authorization or permission for a third-party Legal Zoom or any other third party to go on the website https://dos.fl.gov/sunbiz/ to create or register this incorporation.
- 6. I am listed in the documents that I received from LegalZoom as the incorporator of the Corporation, and my correct address is listed. However, although I am listed as the Corporation's incorporator, I did not incorporate the Corporation. I know nothing about the Corporation and had never heard of it until receiving documents from LegalZoom on April 19, 2024, as set forth in Paragraph 4.
- 7. I also am listed in the documents that I received from LegalZoom as an officer and director of the Corporation, with a Miami address shown for me. However, I do not have any Miami addresses and do not recognize the address that was used. I am not a director or officer of the Corporation.
- 8. It does not appear that the registration fees for the incorporation were paid using my MasterCard. However, on April 23, 2024, my MasterCard fraudulently was used to attempt a credit card purchase, thus further supporting my conclusion that I have been the victim of Identity theft. Furthermore, on April 22, 2024, an attempt was made to open a new U.S. bank account using my name and information, although I did not authorize any such application. Fortunately, the application was denied. I have had to undertake numerous steps to protect my assets and reputation in the days since learning of the theft of my identity.

- 9. The fraudulent actors have also obtained an Employer Identification Number ("EIN") for the Corporation from the United States Internal Revenue Service ("IRS"). I have contacted the IRS to obtain cancellation of that EIN, but the IRS will not do so without proof that the State of Florida has revoked the registration of the Corporation.
- 10. I renew my request that the State of Florida promptly revoke the registration of Oxford Close, Inc.
