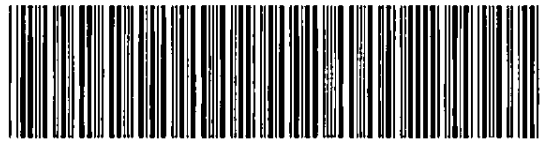

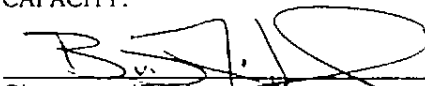

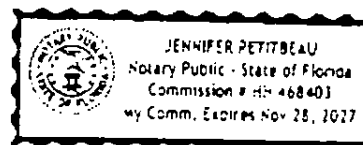
I, BUD HICKS, residing at 11466 NW 81st Place, Parkland, FL 33076, under penalty of perjury, do hereby state the following:
