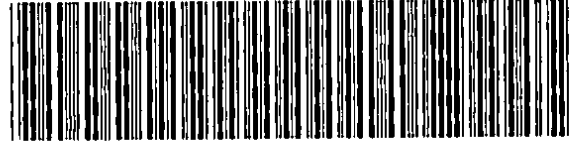

**ARTICLES OF INCORPORATION
OF
VERO BEACH LEGACY, INC.**

The undersigned sole incorporator, for the purpose of forming a corporation pursuant to the provisions of Florida Statutes Section 607.0201 of the Florida Business Corporation Act, as amended, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is Vero Beach Legacy, Inc. (the "Corporation").
