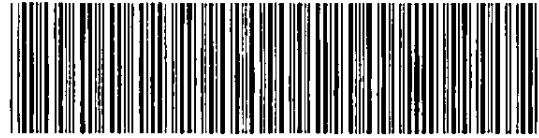

ARTICLE I




