ARTICLES OF INCORPORATION
OF
AXIONLOG TRANSPORTATION, INC.

ARTICLE I

The name of this corporation is Axionlog Transportation, Inc. (the "Corporation").

ARTICLE II

The purpose for which the Corporation is formed is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act (the "Act").

ARTICLE III

The address of the principal office and the mailing address of the office of the Corporation is c/o Stephen Frankel, 11370 New Berlin Road Jacksonville, FL 32226.

ARTICLE IV

The capital stock authorized, the par value thereof, and the characteristics of such stock of the Corporation shall be as follows:

ARTICLE V

The street address of the Corporation's initial registered office is 14 East Bay Street, Jacksonville, Florida 32202, and the name of its initial registered agent at such office is MH Corporate Services, Inc.

ARTICLE VI

- The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws, who will serve as the Corporation's director until successors are duly elected and qualified. The name of the initial directors of the Corporation are Alvaro Carretero, Stephen Frenkel and Gustavo Zuy.

ARTICLE VII

A director or officer of the Corporation shall not be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director or officer, except for liability (i) for any breach of the director's or officer's duty of loyalty to the Corporation or its shareholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law (iii) under Section 607.0834 of the Act, as the same exists or hereafter may be amended, (iv) for violation of a criminal law, unless the director or officer had a reasonable cause to believe his conduct was lawful or had no reasonable cause to believe his conduct was unlawful or (v) for any transaction from which the director or officer derived an improper personal benefit.


If the Act hereafter is amended to authorize the further elimination or limitation of the liability of directors and officers, then the liability of the Corporation's directors and officers shall be eliminated or limited to the fullest extent authorized by the Act, as amended.

The corporation shall indemnify and shall advance expenses on behalf of its directors, officers former directors and former officers to the fullest extent not prohibited by law in existence either now or hereafter.

ARTICLE VIII


