**AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
CENTROID WIRE AND CABLE, INC.**

Pursuant to the provisions of section 607.1006, Florida Statutes, CENTROID WIRE AND CABLE, INC., a Florida corporation, hereby certifies that:

WHEREAS, the name of the Corporation is **CENTROID WIRE AND CABLE, INC.** (the "**Corporation**");

WHEREAS, the Corporation was formed in Florida on May 15, 2024, and was assigned document number P24000033132;

WHEREAS, the following amendments to the Articles of Incorporation were adopted by the shareholders of the Corporation on May 17, 2024, and the number of votes cast by the shareholders for the amendments was sufficient for approval by the Corporation;

NOW, THEREFORE, the Articles of Incorporation of the Corporation are hereby amended and restated in their entirety to read as follows:

"ARTICLE I NAME

The name of the corporation shall be **CENTROID WIRE AND CABLE, INC.**

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
