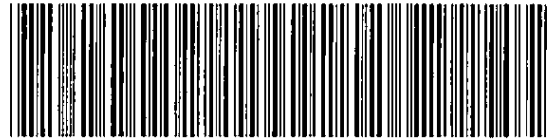

**ARTICLES OF INCORPORATION
OF SXIPHER, INC.**

Pursuant to Section 607.0202, Florida Statutes, Sxipher, Inc. hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **SXIPHER, INC.** ("Corporation" or "Company").

ARTICLE II. PRINCIPAL OFFICE

The initial principal place of business of the Corporation shall be: 1816 Old St Augustine Rd, Florida 32311

ARTICLE III. PURPOSE

The general nature of the business to be transacted by the Corporation shall be

ARTICLE IV. SHARES

Section 1 – *Common Stock*: The total number of shares of all classes of capital stock which the Corporation shall have authority to issue is 10,000,000, consisting of common stock with a par value of \$.01.

Section 2. Directors Authorized to Reclassify. The board of directors is authorized, without shareholder approval, to:

- (a) Classify any unissued shares into one or more classes or into one or more series within a class;
- (b) Reclassify any unissued shares of any class into one or more classes or into one or more series within a class; or
- (c) Reclassify any unissued shares of any series of any class into one or more classes or into one or more series within a class.

ARTICLE V. DIRECTORS

(a) **Number.** The number of directors may be increased or diminished from time to time pursuant to the Bylaws of the Corporation but shall not be less than three nor more than nine.

(b) **Initial Board of Directors.** The initial Board of Directors shall be composed of the following three directors:



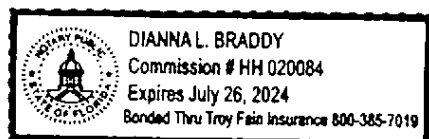


