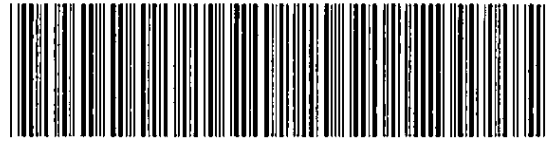

**ARTICLES OF INCORPORATION
OF
KZKS HOLDINGS, INC.**

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

**ARTICLE I
Name**

The name of the corporation shall be KZKS Holdings, Inc. (the "Corporation").

**ARTICLE II
Principal Office**

The street and mailing address of the principal office of the Corporation is 4101 NW 4th St, Suite 104, Plantation, FL 33317.

**ARTICLE III
Registered Office and Agent**

Any repeal or modification of this Article IX by the shareholders of the Corporation will be prospective only and will not adversely affect any limitation on the personal liability of a director of the Corporation existing at the time of such repeal or modification.
