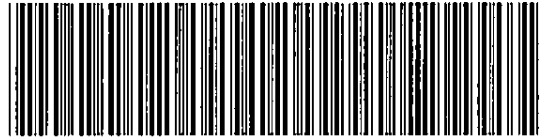

ARTICLES OF INCORPORATION

FOR

EXPERT COMPLIANCE SERVICES, INC.

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be EXPERT COMPLIANCE SERVICES, INC.

ARTICLE II

TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 10 day of July, 2024, and shall exist perpetually.

ARTICLE III

GENERAL PURPOSE
