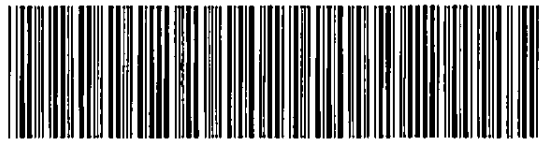

The number of shares of stock the corporation is authorized to issue is 10,000 shares.

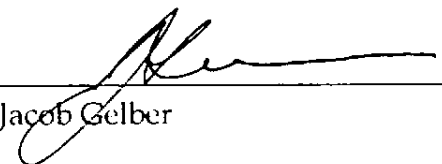

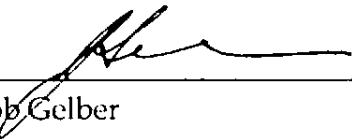
