ARTICLES OF INCORPORATION OF QUANTUM PENSION SOLUTIONS, INC.

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be Quantum Pension Solutions, Inc. (the "**Corporation**").

ARTICLE II: INITIAL PRINCIPAL OFFICE

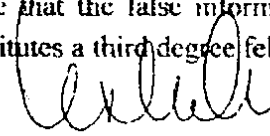
