ARTICLES OF INCORPORATION OF

DATA CENTER CONNECTION, INC.

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation.

Article I. NAME

The name of the corporation shall be DATA CENTER CONNECTION, INC. (the "Corporation").

Article II. INITIAL PRINCIPAL OFFICE

Article III. PURPOSE
