**ARTICLES OF INCORPORATION
OF
CENTRAL FLORIDA CARDIOLOGY SELLER, P.A.**

ARTICLE I—NAME; ADDRESS AND PLACE OF BUSINESS

The name of the corporation is CENTRAL FLORIDA CARDIOLOGY SELLER, P.A. ("Corporation")

The address of the principal office and the mailing address of the Corporation shall be 1825 SALK AVENUE, TAVARES, FLORIDA, 33778.

ARTICLE II—EFFECTIVE DATE AND DURATION; POWERS

These Articles of Incorporation shall be effective on the date filed, and its duration shall be perpetual, unless otherwise terminated in accordance with the Bylaws of the Corporation.

The Corporation is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized by Florida Statutes, Chapter 621 (the "Act"), as amended from time to time.
