ARTICLES OF INCORPORATION OF DOCKMONSTER, INC.

FIRST: The name of this corporation is DockMonster, Inc., a Florida corporation.

SECOND: The address of the corporation's registered office in the State of Florida is. 1200 South Pine Island Road, Plantation, Florida 33324. The name of the corporation's registered agent at such address is C. T. Corporation System. The physical and mailing address of the corporation is 3016 Mercury Road South, Jacksonville, FL 32207.

THIRD: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

NINTH: The corporation shall, to the fullest extent legally permissible under the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any person who was or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, or investigative (other than an action by or in the right of the corporation) by reason of the fact that the person is or was a director or officer of the corporation, against expenses (including attorney's fees), judgments, fines, and amounts paid in settlement actually and reasonably incurred by him or her in connection with any action, suit, or proceeding if the person acted in good faith und inn manner the person reasonably believed to be in or not opposed to the best interests of the corporation, and, with respect to any criminal action or proceeding, had no reasonable cause to

believe the person's conduct was unlawful. Such indemnification or advancement of expenses provided by, or granted pursuant to. Section 607,0850 of the Florida Business Corporation Act, shall not be deemed exclusive of any other rights to which those Indemnified may be entitled under any bylaw, agreement or resolution adopted by the board of directors.

TENTII: The corporation shall not be governed by or subject to Section 607.0901 of the Florida Business Corporation Act.
