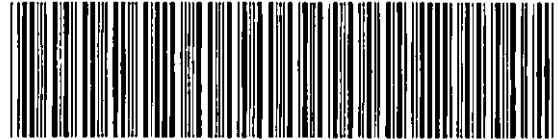

In addition, we noticed that my partners name Adriana Gonzalez Fajet, didn't include her entire name.





**\*\*Meeting Agenda:\*\***

1. **\*\*Impact Royals Agenda\*\***

Discussion centered around developing the agenda for the upcoming Impact Royals initiative. Members agreed to establish the main objectives and themes for each session including dates, merchandise pictures and adding community services hours.

2. **\*\*Dates for Impact Royals\*\***

Proposed dates for Impact Royals were discussed, approved and added to the agenda. Finalized dates will be shared with students and parents in their respective meetings.

3. **\*\*Instagram Creation\*\***

Members agreed to hire someone to create and manage an Instagram account to build an online presence for Impact Self LLC and the Impact Royals program. Unnamed as of yet, was tasked with setting up the account and managing initial content.

4. **\*\*50/50 Partnership Structure\*\***

Both members confirmed the company will operate under a 50/50 partnership. Instead of appointing a President and/or VP or COO, both members will serve as acting secretaries, sharing equal responsibilities in managing the company's operations and strategic decisions.

5. **\*\*Sunbiz Change of Information Submission\*\***

We have decided to change the company structure. The necessary paperwork to reflect the current company structure will be submitted to Sunbiz. This includes the change of positions from COO to "acting secretaries."

6. **\*\*Bank Selection - Chase Bank\*\***

Members agreed to open a business account with Chase Bank to manage company funds. Adriana will contact the bank and ensure the account is set up and ready for deposits. The appointment is scheduled for 9/17/2024

7. **\*\*Student Orientation Structure\*\***

Initial discussions on how student orientations will be structured took place. Members agreed to design a program that includes an introduction to Impact Royals, expectations, and resources available to students.

8. **\*\*Toolbox Development\*\***

A toolbox was proposed to support students with their personal and professional growth during the program using items that represent different skills needed for success. Both Julie and Adriana will begin outlining materials and tools to include in the toolbox, with a focus on leadership, mindset, and conflict resolution.

9. **\*\*Structure for Meetings with Parents\*\***

Discussions on how to engage parents in the process were initiated. Members agreed to hold structured meetings to inform parents about the program and its benefits for their children. Final decisions regarding frequency and content will be made in future meetings. Table set up was discussed, as well as who is bringing what.
