

ARTICLE 1 NAME

The name of the corporation shall be Collier Holdco. Inc. (the "Corporation").

ARTICLE 2 INITIAL PRINCIPAL OFFICE

The street and mailing address of the initial principal office of the Corporation Selph Road, Lakeland, Florida 33810.

ARTICLE 3 PURPOSE

Any amendment, repeal, or modification of this Article 7 shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.
