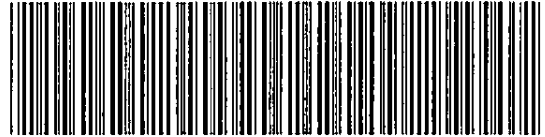

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is CLASSIC BEAUTY BY ANNA K, INC. and its principal place of business shall be located at 2500 Vanderbilt Beach Road, Suite 2200, Unit#107, Naples, FL 34109.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

**ARTICLE IV - CAPITAL STOCK**


