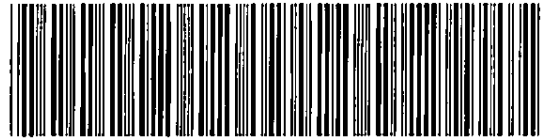


Dear Ms. Howell:
