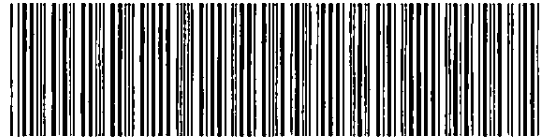

ARTICLES OF INCORPORATION

OF

Pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, the undersigned incorporator **MODULAR RUSH INC.**, a **Florida corporation** (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND PRINCIPAL & MAILING ADDRESS
