**ARTICLES OF INCORPORATION
OF

Pursuant to the Florida Professional Service Corporation and Limited Liability Company Act (the "Act"), the undersigned, acting as incorporator of the above-captioned professional corporation, hereby organizes a professional corporation and adopts the following Articles of Incorporation:

**ARTICLE I




