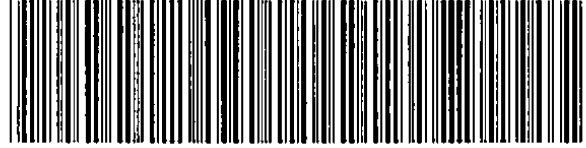

Article IV of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

Article IV

The total number of shares of stock that the corporation has authority to issue will be:

20 shares of Voting Common Stock without par value.

980 shares of Non-Voting Common Stock without par value.

The preferences, qualifications, limitations, restrictions, and the special or relative rights in respect of the shares of each class are as follows:

(a) Except as provided below with respect to voting powers, the rights, preferences, and limitations of the Common Stock will be identical in all respects.

(b) With respect to voting powers, except as otherwise required by Chapter 607 F.S.- Florida Business Corporation Act, the holders of Voting Common Stock will possess all voting powers for all purposes, including, by way of illustration and not limitation, the election of directors. The holders of Non-Voting Common Stock will have no voting power whatsoever, and no holder of Non-Voting Common Stock will vote on or otherwise participate in any proceedings which actions are taken by the Corporation or its Shareholders or be entitled to notification as to any meeting of Board of Directors or the Shareholders."


