

ARTICLES OF INCORPORATION

OF

XTREME SCAPES OF FLORIDA, INC.

ARTICLE I

Name. The name of the Corporation is Xtreme Scapes of Florida Inc. The "Corporation").

ARTICLE II

Principal Office and Mailing Address. The street address of the principal office and the mailing address of the Corporation is 1903 Capital Drive SE, Palm Bay, FL 32909.

ARTICLE III

Business Purpose. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

<u>Capital Stock.</u> The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 2,000 shares of common stock having no par value per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

ARTICLE V

Term of Existence. The Corporation shall have perpetual existence.

ARTICLE VI

<u>Initial Registered Office and Agent.</u> The street address of the initial registered office of the Corporation is 1903 Capital Drive SE, Palm Bay, FL 32909, and the name of the initial registered agent of the Corporation at that address is Eric Rotger.

ARTICLE VII

Number of Directors. The Board of Directors of the Corporation shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the shareholders in accordance with the Bylaws of the Corporation. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at an annual or special meeting. The directors may authorize and require the payment of the reasonable expenses incurred by directors in attending meetings of the directors. Nothing in this Article shall be construed to preclude a director from serving the Corporation any other capacity and receiving compensation therefor.

ARTICLE VIII
