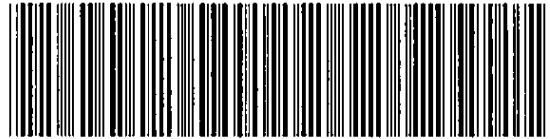

We recently filed for DAZSER-BHM Corporation (a Delaware corporation) to be converted to a Florida corporation under the same name. As the attached letter indicates, our document was not filed because of a missing signature and a conflict with the name of existing entity L07000074110 (DAZSER-BHM PROPERTIES, LLC).

I have attached corrected paperwork with all required signatures. We are asking that the requested name be accepted for the reasons given below.

As the list below shows, a search for the word "DAZSER" returns a list of 18 entities, 11 of which are active. We formed and are the owner of those entities.

We operate 12 businesses in 4 different cities: Baltimore (BAL), Birmingham (BHM), Orlando (ORL), and Tampa Bay (TPA). The names used for each entity all share the unique word "DAZSER," but they also have several components that make their names unique. The system that we've used for entity names is:

DAZSER-XXX, where "XXX" is the 3-letter abbreviation for the city e.g., DAZSER-TPA indicates an entity doing business in Tampa Bay, while DAZSER-ORL indicates an entity doing business in Orlando. We have used this convention when creating entity names in Florida for over 25 years with no conflicts.

"PROPERTIES" or "SERVICES" is the next component in a name. It indicates the nature of the business e.g., PROPERTIES indicates real estate and "SERVICES" indicates cleaning service.

"CORPORATION," "INC," or "LLC" indicate the type of entity.

While the two entities share "DAZSER-BHM" at the beginning of their names, what follows that prefix is easily distinguishable, since one has just the word "CORPORATION" and the other has the words "PROPERTIES, LLC."

Also, the Florida Department of State has always considered this combination of elements to result in a unique name that was clearly distinguishable from others on file e.g., the following entities listed in the search results above have all been deemed distinguishable from each other:

DAZSER-ORL CORPORATION  
DAZSER-ORL PROPERTIES, LLC

and

DAZSER-TPA CORPORATION  
DAZSER-TPA PROPERTIES, LLC

Since these entity names were deemed to be distinguishable from one another, we ask that DAZSER-BHM CORPORATION and DAZSER-BHM PROPERTIES, LCC be given the same approval.
