ARTICLES OF INCORPORATION OF FOSHEE HOLDCO, INC.

The undersigned incorporator, being competent to contract, subscribe to these Articles of Incorporation to form a corporation for profit under the Florida Business Corporation Act (the "Act").

ARTICLE I. Name

The name of this Corporation shall be:

FOSHEE HOLDCO, INC.

ARTICLE II. Principal Office

The address of the principal office and the mailing address of the Corporation is 860 Tilden Oaks Trail, Winter Garden, FL 34787.

ARTICLE III. Business and Activities

This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV. Capital Stock

- Section 1. <u>Capital Stock</u>. The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one thousand (1,000) shares of Common Stock, \$0.0001 par value per share (the "Common Stock").
- Section 2. The holders of the Common Stock shall be entitled to vote upon all matters upon which holders of the Common Stock have the right to vote and shall be entitled to one vote for each such share held by them, respectively.
- Section 3. The holders of all series of the Common Stock shall be entitled to receive, pro-rata, when and as declared by the Board of Directors, out of any assets of the Company legally available therefor, such dividends as may be declared from time to time by the Board of Directors.

No committee of the Board of Directors may pre-empt the Shareholders' Agreement signed by all Shareholders.

This Corporation expressly elects not to be governed by the provisions of Florida Statutes Section 607.0901 dealing with affiliated transactions.
