

SUPLEMENTAL ARTICLES OF INCORPORATION OF B.F. ALERT SYSTEMS, CORP

This Supplemental Articles of Incorporation are executed to ratify and supplement the Articles of Conversion filed in accordance with Fla Statutes § 607.11933 & 607.0202. Both documents have the same effective date of October 4, 2024, and combined shall be deemed to be B.F. Alert Systems. Corp's Articles of Incorporation.

ARTICLE 1: Authorized Stock
