**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I - NAME OF CORPORATION**

The name of this Corporation shall be RAPSEY HOLDINGS, INC.

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address, and the mailing address, of the principal office of the Corporation is c/o Chastang & Partners, LLC, 100 W. Lucerne Circle, Suite 501, Orlando, Florida 32801.

**ARTICLE III - INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.




