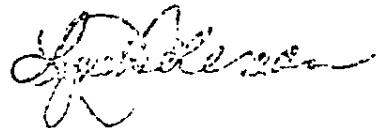

4. This conversion was approved by the converting Eligible Business Entity in accordance with this chapter and the laws of its current/organic jurisdiction.

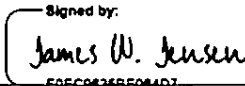

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the Corporation is SDHC HOLDINGS, INC. The street address of the initial principal office of the Corporation and mailing address shall be 2450 W. Nasa Blvd., Melbourne, Florida 32904.

ARTICLE II – PRINCIPAL OFFICE

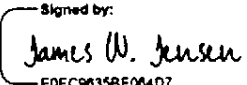
ARTICLE VII – BYLAWS
