**ARTICLES OF INCORPORATION
OF
ALLERX, P.A.**

The undersigned, acting as incorporator of a professional service corporation being formed under the Professional Service and Florida Business Corporation Acts, respectively, Chapters 621 and 607, Florida Statutes, adopts the following articles of incorporation.

ARTICLE I.

Name

The name of the corporation is Allerox, P.A. (the "Corporation").

ARTICLE II.

Purpose




