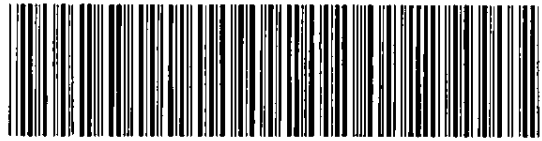

On February 6, 2025, my office mailed in Articles of Incorporation for Broward Casting Company, Inc. A search of the Florida Division of Corporations website resulted in my firm discovering that the Articles of Incorporation submission was rejected. My office, as of the date of this letter, never received notification of the rejection from the Division of Corporations. Accordingly, my office called the Division to inquire into the reason for the rejection. On the call, my office was informed that the reason for the rejection was two reasons: 1) that the proposed name of the corporation contained a double suffix; and 2) that the Registered Agent's name contained initials. My office was informed, and I confirmed, that the filing fee check, totaling \$70.00 (Check No. 14297) was cashed by the Florida Division of Corporations on February 15, 2025. My office was instructed to write this cover letter and include it with corrected Articles of Incorporation removing one of the suffixes from the name of the corporation and providing the full name of the Registered agent.
