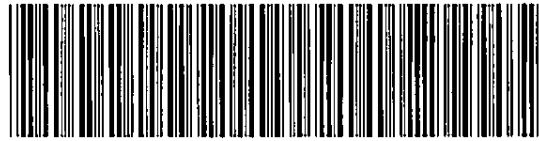

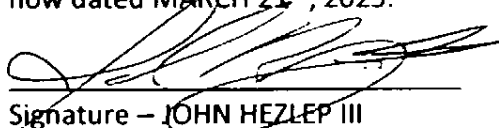

1. Introduction. JOHN HEZLEP III being duly sworn, deposes and says:

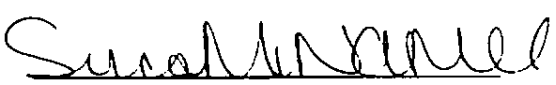

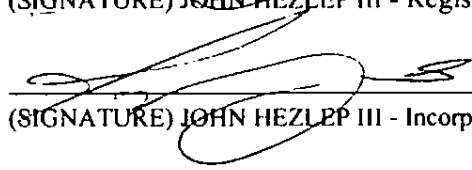
