

## STATE OF DELAWARE CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION OF DATA TRANSMISSION NETWORK CORPORATION

Data Transmission Network Corporation (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware

#### **DOES HEREBY CERTIFY:**

FIRST: That at a meeting of the Board of Directors of the Corporation held on November 29, 2006, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Corporation, declaring said amendment to be advisable and calling for approval thereof by the sole stockholder of the Corporation. The resolutions set forth that the Certificate of Incorporation of the Corporation be amended by deleting and replacing Article FIRST of the Certificate of Incorporation in its entirety so that, as amended, Article FIRST shall be and read as follows:

FIRST. The name of the corporation is DTN, Inc.

SECOND: That all other articles, sections and subsections of the Certificate of Incorporation of the Corporation shall remain unchanged.

THIRD: That the sole stockholder of the Corporation's capital stock, acting at a duly called and constituted meeting in accordance with Section 211 of the General Corporation Law of the State of Delaware, approved said amendment.

FOURTH: That, as a result of the foregoing, said amendment has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

FIFTH: That the foregoing amendment to the Certificate of Incorporation shall be effective upon the filing of this Certificate of Amendment with the Secretary of State of the State of Delaware.
