



We the undersigned, SEIYA TSURUTA and JOHN CALOTTA, being the President and Secretary, respectively, of Sompo Japan Fire & Marine Insurance Company of America (the "Corporation"), certify:

1. The name of the Corporation is: **Sompo Japan Fire & Marine Insurance Company of America.**
2. The Corporation's Charter was filed with the New York State Insurance Department on December 21, 2001.
3. The Corporation's Charter is now in full force and effect and is hereby amended to modify Section of said Charter.


Section 1 of said Charter shall be amended in its entirety, effective January 1, 2017, and replaced with the following so that it reads in its entirety as follows:


**Section 1. The name of the Corporation shall be Sampo America Fire & Marine Insurance Company. The former name of the Corporation was Sampo Japan Fire & Marine Insurance Company of America.**
