- 1. The name of the Corporation is: Sompo Japan Fire & Marine Insurance Company of America.
- 2. The Corporation's Charter was filed with the New York State Insurance Department on December 21, 2001.
- 3. The Corporation's Charter is now in full force and effect and is hereby amended to modify Section of said Charter.
