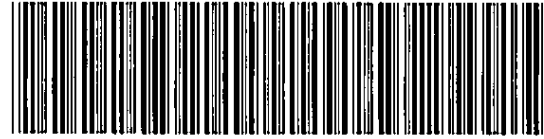

The following articles of merger are submitted in accordance with the Florida Business Corporation act, pursuant to section 607.1105 and 607.1104, Florida Statutes:

FIRST: The name and state of incorporation of each of the merging corporations is as follows:

- NTT DATA Americas, Inc., a Delaware corporation
- Umvel Inc., a Florida corporation ("Domestic Corporation")

SECOND: The name of the surviving corporation is NTT DATA Americas, Inc., a Delaware corporation ("Surviving Corporation") with its principal place of business at 7950 Legacy Drive, Ste. 1100, Plano, TX 75024.
