## CERTIFICATE OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF CHATHAM REINSURANCE CORPORATION

Javier Fernández-Cid and Marc M. Tract certify that:

- 1. They are the President and Secretary, respectively, of Chatham Reinsurance Corporation, a California corporation.
- 2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:

I.

The name of this corporation is Mapfre Reinsurance Corporation.

3. Article II of the Articles of Incorporation of this corporation is amended to read as follows:

Π.

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the California Corporations Code. The business of this corporation is to be an insurer, subject to the provisions of the California Insurance Code. This corporation is organized to transact any class of insurance specifically authorized by its California Certificate of Authority, other than the classes of life, title, mortgage, mortgage guaranty and financial guaranty insurance.

4. The following Article VI is added to the Articles of Incorporation of this corporation:

VI.

- 1. The liability of the directors of this corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.
- 2. This corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors

or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the applicable limits set forth in Section 204 of the California Corporations Code with respect to actions for breach of duty to this corporation and its shareholders.

- 3. Any amendment, repeal or modification of any provision of this Article VI. shall not adversely affect any right or protection of an agent of this corporation at the time of such amendment, repeal or modification.
- 5. The following Article VII is added to the Articles of Incorporation of this corporation:

VII.

The existence of the corporation is perpetual.

- 6. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.
- 7. The foregoing amendment of articles of incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is 70,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
