

We, the undersigned, pursuant to the provisions of N.J.S.A. 17:26-1, hereby execute the following Certificate of Amendment to the Articles of Redomestication and Restated Certificate of Incorporation (the "Certificate of Incorporation") of Mapfre Reinsurance Corporation, and do certify and state as follows:

- 1. The name of the corporation is Mapfre Reinsurance Corporation (the "Corporation").
- 2. The Certificate of Incorporation is hereby amended to: (i) change the Corporation's name to Mapfre Insurance Company; (ii) increase the par value of the Corporation's common capital stock from \$277,142.86 per share to \$1,700,000 per share effective May 23, 2007; and, (iii) to decrease the number of shares of the Corporation's stock from 16 to 3 effective May 25, 2007. These amendments shall be self-executing, and shall be effected by deleting Article First and Article Fifth of the Certificate of Incorporation in their entireties and replacing them with the following as of the respective effective dates of the amendments:

Effective May 23, 2007, Article First of the Certificate of Incorporation shall be deleted in its entirety and replaced with the following:

FIRST: The name of the corporation shall be Mapfre Insurance Company (the "Corporation.").

Record and Return to:

Michael Dougherty, Esq. Katten Muchin Rosenman LLP 575 Madison Avenue New York, New York 10022-2585 Effective May 23, 2007, Article Fifth of the Certificate of Incorporation shall be deleted in its entirety and replaced with the following:

FIFTH: The amount of capital stock of the Corporation shall be \$27,200,000 (Twenty Seven Million Two Hundred Thousand Dollars) divided into 16 (Sixteen) shares of common capital stock having a par value of \$1,700,000 (One Million Seven Hundred Thousand Dollars) per share. This Article Fifth shall become null and void effective May 25, 2007, and shall be replaced by a new Article Fifth as specified herein.

Effective May 25, 2007, Article Fifth of the Certificate of Incorporation shall be deleted in its entirety and replaced with the following:

FIFTH: The amount of capital stock of the Corporation shall be \$5,100,000 (Five Million One Hundred Thousand Dollars) divided into 3 (Three) shares of common capital stock having a par value of \$1,700,000 (One Million Seven Hundred Thousand Dollars) per share.

- 3. The Board of Directors declared the foregoing amendments to the Certificate of Incorporation to be advisable and adopted a resolution by unanimous consent at its March 7, 2007 meeting to amend the Certificate of Incorporation as provided for above.
- 4. The foregoing amendments to the Certificate of Incorporation were authorized via unanimous written consent, dated March 7, 2007, of the sole stockholder of the Corporation entitled to vote on such matters.
